Photographs of the officer(s), the suspect, and/or the suspect's vehicle involved should be sent as a JPEG by e-mail to dessr@nd.gov.

The Bureau of Criminal Investigation and Highway Patrol will review the request form to determine if criteria is met and authorize activation of the BLUE Alert and dissemination to the media. State Radio will activate the BLUE Alert on law enforcement radio and teletype.
